Roger Neilson House's Commitment to Privacy

In order to provide the best care possible, we need to collect and use information about you, your child and your family. Roger Neilson House is committed to keeping your information safe and confidential and we follow the rules set out in law about collecting, using, and disclosing your information.

How We Protect Your Information

We have safeguards (i.e. security, passwords, and policies) in place to make sure personal information stays private. Only people who need to see your personal records are allowed to look at them.

Consent

In general, we assume that you give consent to share personal information with people involved in the care of your child and we will ask for your consent before we collect, use, or share you information for any purpose other than our stated activities. You may also withhold or withdraw this consent at any time by contacting us.

Who Can Look at Personal Information

Roger Neilson House will give personal information to only those people who need it and have a right to it by law. The people who may see your child's information include the following:

- You or the person responsible for making decisions for your child
- Your child's care providers, both inside and outside the hospice
- People working for a health agency, such as the Ministry of Health, if required by law
- Other people for whom you have given your consent or when required by law

Your privacy is important to us...



We May Use Your Personal Information To:

Provide Care. Personal information is used by care providers and trainees who are part of the health care team.

Improve Care. We may use personal information to improve the care we provide by conducting quality improvement activities to help keep families safe.

Teach. Personal information may be used to support our partnership with the University of Ottawa and other schools, while adequately protecting your privacy.

Conduct Research. Researchers may use your health information, with your consent, while working on a study approved by the CHEO Research Ethics Board.

Conduct Satisfaction Surveys. We care about our patients and want to hear from you about the quality of care and service your child receives. We use this information to help improve the care that we will provide in the future.

Fundraise. The Ottawa Senators
Foundation is dedicated to supporting Roger
Neilson House by raising funds for research,
program operation, and the improvement of
patient care. We share only your name and
address with the Ottawa Senators Foundation
so they can contact you in the event of a donation made on behalf of your child/family.
